


2	<p><b>Presidents Report</b></p> <p>Two donations approved and actioned since the lasted AGM: \$2000 paid to Springfield Quarry for exclusive use by the Christchurch Park Rangers for Port Hills track maintenance and development, and \$2000 to Hato Hone St John. 3	<p><b>Finances</b></p> <p>Henry presented a breakdown of the clubs' income and expenditure till year ended 31 March 2024. This will be checked by an approved auditor and a financial statement created for submission to the companies register.</p> <p>This is required for our incorporated status allowing membership of MTBNZ, which provides our third-party insurance cover.</p> <p>Total Income for the Year was a \$2,498.00 (loss) due to four donations totalling \$4000. The two donations in 23/24 financial year were to \$2000 to the Westpac Rescue Helicopter and \$2000 to Hato Hone St Johns. These funds to be used to support their activities.</p> <p>Subs received \$1557. (Down 17% from previous financial year)</p> <p>MN, seconded HG.
